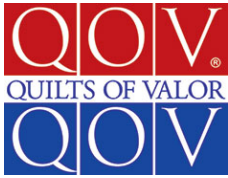
Registration: There are two ways to register a Quilt Business:

1. On-Line: Complete the Certified Quilt Business Registration, Certified Business Financial Responsibility Form and payment on-line, [click HERE](#)
2. Paper Form: Use the PDF form below (page 2 & 3). The form can be filled out by computer or printed and handwritten.
 - a. Enter information as requested on the registration form.
 - b. Quilts of Valor® Foundation is a 501(c) (3) not for profit foundation. To assure proper fund raising and handling of donated monies, this one-time form is required and will be retained by QOVF®. Complete the [Certified Business Financial Responsibility Form](#).

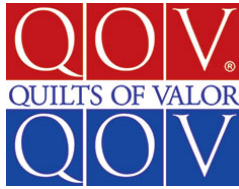
